SECTION 2 – IDENTIFY AND DESCRIBE CATASTROPHE

Section 552.2325(a)(1) defines catastrophe as a "condition or occurrence that directly interferes with the ability of a governmental body to comply with the requirements of this chapter[.]" However, section 552.2325(a)(2) further clarifies that catastrophe "does not mean a period when staff is required to work remotely and can access information responsive to an application for information electronically, but the physical office of the governmental body is closed." SECTION 3 – SUSPENSION PERIOD

The governmental body may suspend the applicability of the requirements of the Act only once for each catastrophe. The initial suspension period may not exceed seven consecutive calendar days. A governmental body may not submit a catastrophe notice more than two calendar days prior to the beginning date of the suspension period. If the catastrophe impact is longer than seven calendar days, a governmental body may submit an extension notice at the end of the initial suspension period. A governmental body may only file one extension notice, and the extension notice may not exceed seven consecutive calendar days. However, the combined suspension period of both the initial and extension may not exceed a total of 14 consecutive calendar days with respect to any single catastrophe. See Gov't Code §552.2325(d), (e), and (g).

SECTION 1: Provide the name of the governmental body impacted by the catastrophe. Section 552.2325(a)(1) of the Government Code defines catastrophe as "a condition or occurrence that directly interferes with the ability of a governmental body to comply with the requirements of this chapter[.]"

SECTION 2: Identify and provide a detailed description of the catastrophe, including how the catastrophe interferes with the ability of the governmental body to comply with the requirements of the Act. The catastrophe description should enable any person who views this notice to readily identify the catastrophe and its impact on the governmental body.

SECTION 3: Provide the dates of the initial suspension period of the governmental body. The suspension may be instated for a period of up to seven consecutive calendar days. The beginning date is counted as part of the suspension period, and it may not be more than two calendar days before submission. The initial suspension period may begin up to two calendar days before the governmental body provides proper notice to the OAG, but it may not be for longer than seven consecutive calendar days, including the beginning date of the suspension period. It also may not be for more than seven calendar days after notice is submitted.

SECTION 4: Provide the contact information of the governmental body's Public Information Officer or an authorized agent. The person listed should be able to answer any questions the OAG may have regarding the governmental body's catastrophe notice.

PUBLIC INFORMATION ACT CATASTROPHE NOTICE EXTENSION INSTRUCTIONS

SECTION 1: This page should not be filled out unless the governmental body has determined it is still impacted by the catastrophe on which the initial suspension period was based. *See* Gov't Code §552.2325(e).

SECTION 2: Provide the beginning and end dates of the initial suspension period and identify the catastrophe listed on the initial notice of catastrophe form.

SECTION 3: Provide the dates for the extension of the initial suspension period. The suspension period may be extended an additional seven consecutive calendar days. The suspension period may only be extended one time and must begin on the calendar day following the end date of the initial suspension. The total time frame of the suspension period should not exceed fourteen calendar days. A copy of this form noting the extension must be provided to the OAG. The extension notice should be signed by the governmental body's Public Information Officer or an authorized agent.

SECTION 4: Provide the contact information of the governmental body's Public Information Officer or an authorized agent. The person listed should be able to answer any questions the OAG may have regarding the governmental body's catastrophe notice.
