Dear Mr. Valdez:

This letter is to inform you that we are withdrawing LO-88-112. A provision has been brought to our attention that we did not consider when we considered the question of whether funds generated by forfeitures under section 5.08 of article 4476-15 are required to be deposited in the county depository.

Section 5.082(a) of article 4476-15, which we did not consider, provides:

> If money is seized by a law enforcement agency in connection with a violation of this Act, the state or the political subdivision of the state that employs the law enforcement deposit the agency may money in interest-bearing bank account in the jurisdiction of the agency that made seizure or in the county in which the money was seized until a final judgment is rendered concerning the violation.

It has been suggested that the specific language of section 5.082 prevails over the general language of section 116.002 We are withdrawing LO-88-112 to of the Government Code. consider that argument.
