Re: Request for Opinion regarding Service Fee

Dear General Abbott:

This letter is written to request your opinion on a matter of Texas law regarding a consumer transaction at an establishment such as a fast food restaurant. The issue involves such an establishment charging an itemized "Service Fee" and offering a "Cash Discount" in connection with a consumer transaction in this state. The law seems to be clear that offering a "Cash Discount" is acceptable in Texas. 15 U.S.C. §16930-2(b)(2)(Supp. I 2010); U.S. et al. v. American Express Co., et al, In the United States District Court for the Eastern District of New York (Final Judgment at p. 6, para. IV.A.1) (prohibiting restraints on Merchants from offering Customer discount for paying with cash).

I seek your opinion on whether or not Texas law also permits an establishment such as a fast food restaurant to charge an itemized and disclosed "Service Fee" in connection with a purchase by a consumer. The service fee will be for a small, fixed amount and will not be percentage based.

I am attaching examples of such a Service Fee.


- Example 1 is an example of the disclosure of the Service Fee and Cash Discount that is placed on the consumer's side of the cash register.
- Example 2 is an example of a register receipt that reflects a 40 cent Service Fee charged in connection with a cash purchase above \$10. (This example includes a separate 50 cent discount for paying with cash).
